CLEAR & SIMPLE DISCOUNTS

FCA Canada Inc. has set up a simple and easy process to use discount structure that provides TRUE FLEET concessions/discounts on vehicles such as 1500/2500/3500 RAM Trucks, 3500/4500/550 RAM Cab & Chassis, RAM ProMaster & ProMaster City plus most of the common passenger vehicle line-up. Under this proposal, the company only needs to be a current ACHCCS (Atlantic Canada Health Care Coalition Society) member to qualify for discounts that are substantially better than their standard fleet discounts.

Fleet concessions are in lieu of ALL retail incentives and cannot be used in conjunction with other discounts or incentive. ACHCCS (Atlantic Canada Health Care Coalition Society) Fleet Discounts are deducted from DEALER COST and NOT Manufacturers Suggested Retail Price (Window sticker price).

In other words, an ACHCCS (Atlantic Canada Health Care Coalition Society) member pays DEALER COST, LESS the Fleet Concession plus the negotiated dealer profits. (Plus freight and applicable taxes).
